TRANSPORT OF PALLETISED GOODS

We offer transport services under ambient conditions or the required temperature regime throughout the EU, as well as for the Western Balkans and Turkey in cooperation with our partners.

HIGH VOLUME TRANSPORT

Our vehicles can transport up to 120 m³ of goods to your desired destination.

TRANSPORT OF CONTAINERS

From all North Adriatic ports, we offer an EU-wide road transport service for all types of containers. We will custom clear the goods for you as well.

TRANSPORT OF COIL SHEETS

Transport of all types of coils for the automotive industry, construction, and white goods manufacturing.

Depending on your preferences, goods are placed on smaller or larger pallets for easier distribution.

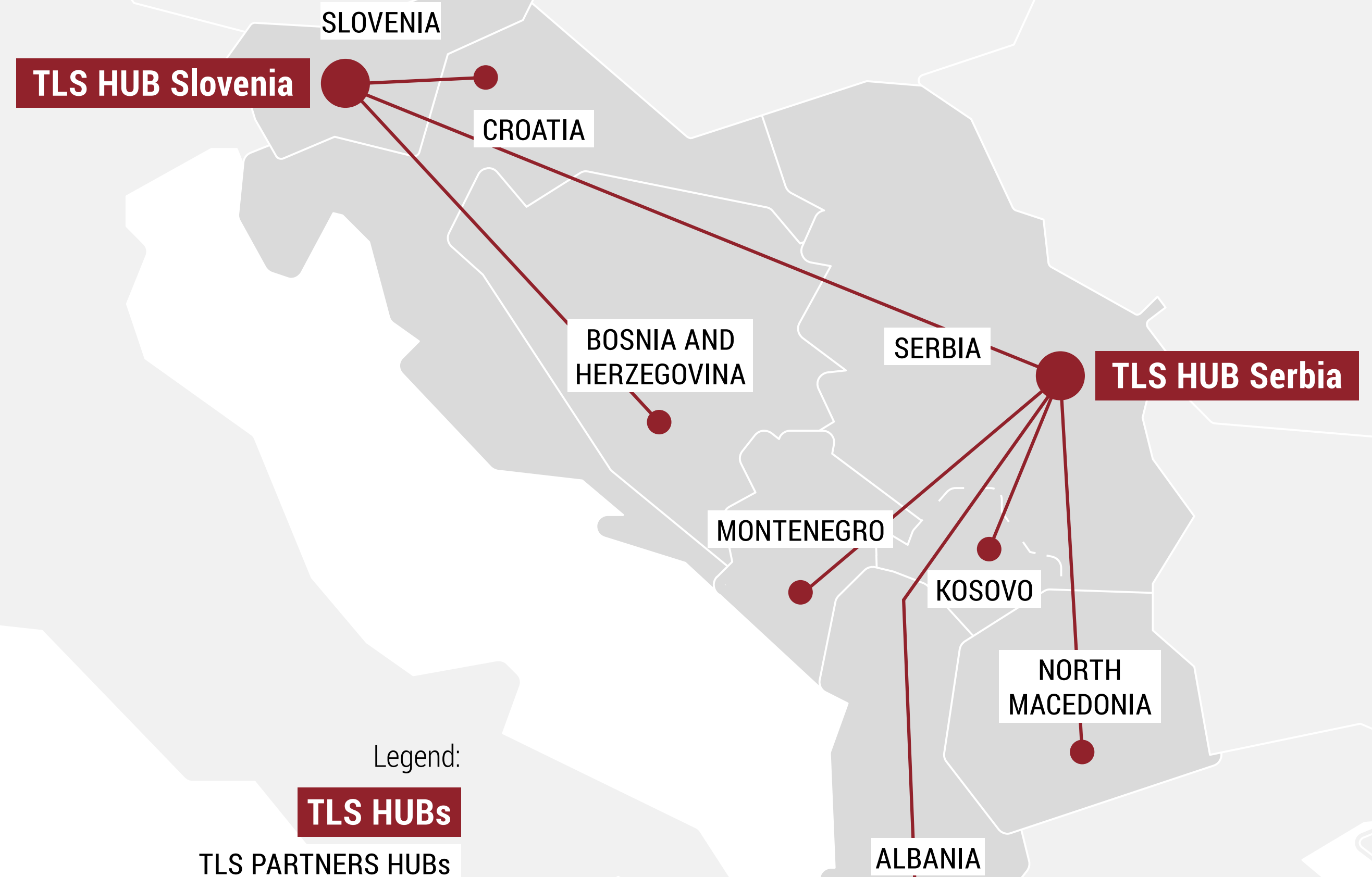
